#### **1. Date, Time and Venue of the meeting:**

The Extra Ordinary General Meeting of the Company was held on Saturday, August 30, 2025 and the meeting commenced at 11:00 A.M. at the Registered Office of the Company and the Meeting concluded at 12:45 P.M.

#### **2. Proceedings in brief:**

- Mr. Pareshkumar Subodhchandra Shah, Managing Director chaired the proceedings of the meeting.
- The requisite quorum being present, the Chairman called the meeting to order.
- The Chairman addressed the members.
- The Chairman informed that remote e-voting commenced at 09:00 A.M. on August 27, 2025 and concluded at 5:00 P.M. on August 29, 2025.
